to the district offices. It is positioned 190km northeast of the Capital City Kampala, 50kms west

of the Regional city Mbale. It is 5km North of Lake Lemwa, 100kms South of Soroti

International Airport.It is bordered by Serere and Kumi districts in the NorthEast, Ngora in the

North, Butebo, Kibuku and Budaka Districts in the East.It lies astride latitudes 1:45°N and

1:05°S and between longitudes 33:47°E and 34:05°W with an area coverage of 32.4 square
