CHAPTER ONE

1.0 INTRODUCTION

1.1 Background

It is widely acknowledged that for children to maximize their potential from Schooling, they need the full involvement of their parents. Parents are children's first and best teachers, and parents can do a variety of things to support their children's literacy development[1]. Parental involvement with children and the school are a critical factor that can produce great benefits for everyone concerned[1]. A substantial body of evidence confirms the benefits of parental involvement in children's education and literacy activities. Research shows that parental involvement has more positive effect on the education and literacy development of their children than other family background variables, such as social class, family size, and level of parental education; that it improves student emotional well-being[2]; that parents involving themselves with their children school progress yields positive results on improved educational performance, greater cognitive competence, and greater problem-solving skills and fewer behavioral problems[3].

Parent involvement in a child's early education is consistently found to be positively associated with a child's academic performance. Specifically, children whose parents are more involved in their education have higher levels of academic performance than children whose parents are involved to a lesser degree. The influence of parent involvement on academic success has not only been noted among researchers, but also among policy makers who have integrated efforts aimed at increasing parent involvement into broader educational policy initiatives[1].

Traditionally, parental involvement in education included contributions to their children's home-based activities (like helping with homework, encouraging reading and school attendance), and school-based activities (like attending Parents Teachers' Association meeting, Parent/Teacher conferences, and participating in fund raising activities). Uzoechina and Obidike (2008) contend that parental involvement in children's education now is manifested in their interest in school activities and active participation in children's school work. Some of these activities are fund-raising, inter-house sports, involvement in school's decision making, information dissemination,
